1. The Board of Directors of the Manhattan Area Technical College met in Regular Session at the MATC library on Tuesday, April 11, 2006, at 7:00 p.m.

4. OWNERSHIP LINKAGE

Jerry Mayo advised that the board of directors has received positive comments about MATC from the GAC/PAC Committees.

5. INCIDENTAL INFORMATION

Rebecca Claus briefed on NLNAC accreditation. The NLNAC is scheduled to visit the MATC ADN Program on October 10 and 12 of 2006. The Nursing Program received their first accreditation in 2001 for 5 years with no follow-up reports. The 2006 accreditation will be for 8 years. The Self Study will be completed by The Nursing Program.

Dr. Edleston introduced Mark Claussen, MATC's new Director of Development. He will meet with the faculty to find out their needs and wants. He will establish a networking foundation for MATC. Mr. Claussen requested that the board members, faculty, and staff provide a list of trustees. Ron Bell announced that the faculty feels positive about his position at MATC.

6. BUSINESS

Dr. Wika announced that the screening committee for BOD Pottawatomie County applicant met on April 4, 2006 and out of 5 applicants, selected Marla Brandon. She will complete the unexpired 4 year term. Dr. Wika moved that Marla be selected to represent Pottawatomie County. John Kice seconded. Motion carried 5/0.

Dr. Edleston provided the CTE Brief update. Dr. Edleston asked for any changes to the proposed chart. The next step it to present to the KBOR. One college President will be selected to be on the review panel. Stacy Kohlmeier moved that the board accept the proposed plan. Dr. Wika seconded. Motion carried 5/0.

Dr. Norris Wika moved for the Board to go into Executive Session with only Board members, to discuss personnel matters on non-elected personnel in order to protect the privacy interests of the individual(s) to be discussed, and that they return to open session in this room at 8:00 p.m. Dale Shipps seconded. Motion carried 5/0. Board returned to regular session at 8:00 p.m. No action taken.

John Kice motioned that the board table the Monitoring Reports until May 9, 2006 due to absent board members. Dale Shipps seconded. Motion carried 5/0.

The board is planning on scheduling a Carver Model Seminar for the MATC faculty, which will be based on the board's interpretation of the Carver Model. The board will also give a comparison between the Traditional Model of a board and the adopted Carver Model. The board will also discuss reasons for the switch. Seminar time and date is to be announced.

ADN is scheduled to move from Cloud County Community College (CCCC) to MATC by July 2006. Dr. Edleston described the layout of the plan for the new classrooms. The move will save MATC money, allow more classroom space, allow nursing staff in one facility, eliminate scheduling conflicts, have little or no effect on CCCC. There are no negatives for the move.
